

一、賽制

- (a) 如參加之單位只有六隊或以下，採用單循環比賽。倘參加之單位有七隊或以上，則採用分組單循環比賽，以最佳成績之兩隊參加準決賽及決賽。每組第三，四名順序參加名次賽，全部採用交叉淘汰制。
- (b) 每場比賽五盤，每盤五局三勝制，每局 11 分，以先勝三盤者為勝。
- (c) 比賽次序：(i) 第一單打 (ii) 第二單打 (iii) 第一雙打 (iv) 第二雙打 (v) 第三單打

二、規則

除賽會特別訂明外，其他規則一律採用最新（該年度九月份）國際乒乓球協會編訂之規則。

三、計分辦法

- (a) 單循環比賽勝一場得 2 分，負一場得 1 分，棄權或被取消資格得 0 分。
- (b) 倘積分相同時，兩隊同分隊伍以勝者為勝。倘三隊或以上積分相同，首先計算有關隊伍相互比賽勝場次數多者名次列前。如勝場次數相同，則計算相同隊伍的對賽成績，勝者為勝。如仍未能分出勝負，則計算相關隊伍盤數之勝負率，多者名次列前。若仍未能分出勝負，則計算相關隊伍局數之勝負率，多者名次列前。倘若再相同則計算相關隊伍每局分數之勝負率，多者名次列前（計算公式：勝負率 = 得盤 / 局 / 分 ÷ 失盤 / 局 / 分）。
- (c) 倘結果仍然相同，則由有關隊伍重賽（此項只適用於出線隊伍產生之情況下）。

四、報名

- (a) 每院校限報男女子各一隊，運動員經填報後不得更改（包括資料及相片），報名表須經董事局成員簽署及蓋上院校印鑑。
- (b) 每隊報名人數不得超過八人及不得少於四人。
- (c) 合資格參賽年齡為1988年1月1日至1999年12月31日。

五、改期

賽程經主委編定後，各院校不得要求改期。若有特別事故，主委有權更改賽期。

六、裁判

由比賽主委聘請合格裁判擔任。

七、棄權

- (a) 到達法定比賽時間，參賽隊伍未能派出合法人數出賽者（不少於四人），判作棄權論（以場地大鐘為準；如沒提供，則以主委手機網絡時計為準）。
- (b) 球賽進行之中之任何爭議，倘已明文規定者或有同等意義註明者，由裁判判定，不得異議。比賽須繼續進行，如有隊伍放棄繼續比賽，作棄權論。
- (c) 棄權隊伍均須就棄權一事作書面解釋（比賽後七十二小時內“假期計算在內”）。該書面信函須由董事局成員簽署。

八、抗議及上訴

賽後如有抗議提出上訴者，應在賽後七十二小時內（假期計算在內）以書面提出。該書面信函須由董事局成員簽署，連同保證金港幣壹仟圓，送交比賽主委提出上訴，經由上訴委員會審判後為最終判決。

九、天氣

舉行比賽當日如遇惡劣天氣，主委有權決定賽事應否依期舉行。

十、附則

- (a) 比賽用球採用白色『雙魚』乒乓球（40mm+），由賽會提供。
- (b) 每一球員在每比賽中祇能參加一盤單打及一盤雙打比賽。
- (c) 第一單打及第二單打之球員不能參加該隊的第一雙打。
- (d) 如比賽時間超出預期，在情況許可下，主委可要求用兩張球檯同時進行相同隊伍之比賽，球隊不得異議。主委只會提供10分鐘熱身時間予雙方熱身。
- (e) 如有需要，初賽期間將安排一天進行三節的比賽時段，而部份隊伍可能需要被安排一天內進行兩場賽事。
- (f) 本章程及其注意事項如有未盡善之處，主辦單位得隨時修訂，並提交大專執委會通過後實施。



1. Format of Competition

- (a) A single round-robin system will be adopted in the preliminary round if the number of participating team is six only. If the number of participating team is more than six, teams will be drawn into two groups. The top two teams in each group will qualify for the final. Teams finishing at 3rd and 4th places in the groups will play for the consolation round adopting the cross-elimination system.
- (b) All matches will be played by 3 sets out of 5 system. Each set will be played by 3 games out of 5 system, and each game carries 11 points.
- (c) Play Order : (i) 1st Singles (ii) 2nd Singles (iii) 1st Doubles (iv) 2nd Doubles (v) 3rd Singles

2. Regulations

Unless otherwise stated, the competition shall be organized in accordance with the most recent (until last September) technical regulations of the “The International Table Tennis Federation” (ITTF).

3. Scoring

- (a) Two point shall be awarded for a win, one point for a loss, and zero point for failing to honour a fixture.
- (b) In case of equality of ranking between teams in the preliminary round, the following shall be adopted to decide the position.
 - If a tie exists between two teams, the team that wins at the match shall be accorded a higher position;
 - If a tie exists among three teams or more, the position of teams shall be decided by:
 - 1) If a tie still exists among teams, the set quotient shall be adopted; set quotient – division of the number of all sets won (dividend) by the number of all sets lost (denominator), the team with the larger quotient shall be ranked higher;
 - 2) If a tie persists after the set quotient system has been performed, the game quotient shall be adopted; game quotient – division of the number of all games won (dividend) by the number of all games lost (denominator), the team with the larger quotient shall be ranked higher;
 - 3) When a tie still exists among the teams after calculation of the set games, the position shall be decided by the point quotient – division of the number of all points won (dividend) by the number of all points lost (denominator), the team with the larger point quotient shall be ranked higher;
 - 4) If a tie persists after the point quotient system has been performed, a re-match will be arranged (only applicable to teams involved in second round matches).

4. Entries

- (a) Each institution is entitled to enter one men’s team and one women’s team. The personal information with recent photos of the student-athletes should be put down clearly on the enrollment form, duly signed by Council Member of respective institution with school chop.
- (b) A team may consist of 4 to 8 players.
- (c) Eligibility of student-athletes : date of birth from 01/01/1988 to 31/12/1999, registered for full-time studies at the respective institutions

5. Postponement

Request for postponement will not be entertained. Under special circumstances, the convenor has the right to change the competition schedule.

6. Referees

Certified referees will be responsible for the referee services.

7. Withdrawal

- (a) Any team not presenting a minimum number of players (not less than four) required for a particular game at the scheduled competition start time (according to the clock at the stadium; if not applied, Convenor's mobile service provider time signal is adopted). Shall be disqualified for the match.
- (b) In case of any dispute, the decision of the referee made according to the relevant rules of table tennis shall be final. Should a team refuse to play after the decision, the opposing team shall be awarded a walk-over.
- (c) The team disqualified as specified in 7(a) above should submit an official explanation signed by the Council Member of the institution concerned to the Chairman of the Executive Committee of USFHK within 72 hours (irrespective of holidays) of the event.

8. Protest and Appeal

Each and every appeal must be made in writing and signed by the Council Member of the institution concerned. The appeal, accompanied with a deposit of Hong Kong dollars one thousand, shall be made within 72 hours (irrespective of holidays) of the event concerned, to the convenor and copied to the Chairman of Executive Committee. The decision of the Appeal Board shall be final.

9. Weather

In case of adverse weather, the convenor has the right to postponement of matches.

10. By-laws and Rules

- (a) White "Double Fish (40mm+)" has been adopted as official ball used for competition.
- (b) Each player can participate in 1 Singles match and/or 1 Doubles only °
- (c) 1st & 2nd Singles players cannot participate in 1st Doubles.
- (d) If the circumstances allows and the game overtime, convenor can request the competitive team to separate with two tables at the same time to play the game. Convenor should provide 10 minutes for warm-up time. Not complying with the regulations.
- (e) If necessary, there will be arranged 3 sessions of the game a day during the preliminary round. A part of the team may need to be arranged for 2 games a day.
- (f) The organizer reserves the right to amend and/or supplement the By-Laws, Rules and Regulations. The By-Laws, Rules and Regulations thus made will be submitted to the Executive Committee for approval.
- (g) In case of controversy over the rules/regulations between the Chinese and the English versions, the interpretation of the Chinese version shall be followed.



2016-17 年度大專乒乓球比賽

注意事項

- (1) 本年度首次出賽的球員，必須於比賽當日開賽前十五分鐘，帶同身份證明文件正本（證件號碼須與報名表相同），親臨「司令台」辦理驗證手續，方可出賽。
- (2) 請各隊於**開賽前十分鐘**交回出場紙。出場紙一經遞交後，不得更改。
- (3) 當日登記表上的作賽球員，必須於法定開賽時間前，齊集比賽場館內等候主委或工作人員數算出場人數，**不足指定球員之隊伍**，將會被取消當日比賽資格，作棄權論。
- (4) 每隊可派五名負責人坐於教練席，每盤比賽都可由不同的人負責，惟必須於出場紙上登記各負責人姓名。如該負責人並非登記於報名表上的教練，他並沒有教練的權利。
- (5) 初賽時，對賽雙方須各派一名熟識球例的代表任主裁判及計分員工作；準決賽及決賽時，則聘請合格裁判擔任之。
- (6) 第一盤比賽的運動員必須於數算出場人數後立即開始作賽。
- (7) 為免影響觀眾及場館內空氣，請在場館以外，空氣流通的地方使用快乾膠。
- (8) 場館內只可飲用清水，不得進食或飲用其他飲料。
- (9) 大會對打氣用品並沒有特別規限。若主委收到有關打氣聲浪影響比賽的投訴時，主委有權禁止該行為，請各院教遵守及合作。
- (10) 各院校如安排人手攝錄煩請到「大會指定攝錄區」。
