

# 中國香港大專體育協會女子手球比賽 2025-26

## 章則



### 一. 賽制

如參加之單位只有六隊或以下，將採用單循環比賽。倘參加之單位有七隊或以上，則採用分組單循環比賽，以最佳成績之兩隊參加準決賽及決賽。每組第三、四名順序參加名次賽，全部採用交叉淘汰制。

### 二. 規則

除賽會特別訂明外，其他規則一律採用2025年7月1日國際手球聯會編訂之規則。

### 三. 計分辦法

(a) 單循環比賽勝一場得3分，賽和雙方各得1分，負一場得0分，棄權或被取消資格得0分及被判負0比12。分組名次按積分多寡而定。

(b) 倘兩隊或以上積分相同，則按下列辦法計算分組名次：

(i) 有關隊伍相互間比賽，勝場次數多者名次列前；

(ii) 相關隊伍相互間比賽得失球差，多者名次列前；(計算方式：得失球差 = 得球 - 失球)

(iii) 相關隊伍相互間比賽的總進球數，多者名次列前；

(iv) 倘再相同，則計算全部比賽之得失球差，多者名次列前；

(v) 相關隊伍全部比賽的總進球數，多者名次列前。

(c) 倘結果仍然相同，則由有關隊伍重賽(此項只適用於出線隊伍產生之情況下)。

(d) 分組賽每場比賽完結時，雙方平手，不用加時，雙方各得1分。

(e) 準決賽及決賽賽事，如於法定時間賽和者，將會加時上、下半場各5分鐘決勝負，仍賽和才以射七米球決勝負。其餘複賽賽事如賽和者，則直接射七米球決勝負。

### 四. 報名

(a) 每院校限報女子隊一隊，運動員經填報後不得更改(包括資料及相片)，報名表須經董事局成員簽署及蓋上院校印鑑。

(b) 每隊報名人數及在場註冊人數均為十六人。

(c) 運動員須為全日制學生，於1990年1月1日至2008年12月31日期間出生。

### 五. 改期

賽程經主委編定後，各院校不得要求改期。若有特別事故，主委有權更改賽期。

### 六. 裁判

由比賽主委聘請合格裁判擔任。

### 七. 棄權

(a) 到達法定比賽時間，參賽隊伍未能派出合法人數出賽者〔不得少於五人〕，判作棄權論(以場地大鐘為準；如沒提供，則以主委手機網絡時計為準)。

(b) 球賽進行之任何爭議，倘已明文規定者或有同等意義註明者，由裁判判定，不得異議。比賽須繼續進行，如有隊伍放棄繼續比賽，作棄權論。

(c) 棄權隊伍均須就棄權一事作書面解釋(比賽後七十二小時內“假期計算在內”)。該書面信函須由董事局成員簽署。

### 八. 抗議及上訴

賽後如有抗議提出上訴者，應在賽後七十二小時內(假期計算在內)以書面提出。該書面信函須由董事局成員簽署，連同保證金港幣叁仟圓，送交比賽主委及副本抄送執行委員會主席提出上訴，經由上訴委員會審判後為最終判決。

### 九. 天氣

舉行比賽當日如遇惡劣天氣，主委有權決定賽事應否依期舉行。

## 十. 附則

- (a) 比賽用球採用“Kempa Spectrum Synergy Pro size 2”手球，由賽會提供。
- (b) 球衣方面，如對賽雙方顏色相同，客隊（對賽後者）需作出調動，穿著另一顏色的球衣。
- (c) 團隊暫停：本賽事並沒有利用電子蜂鳴器作為球隊要求”團隊暫停”之用。『綠卡系統』仍然有效。
- (d) 『視頻回放規則』：本賽事不適用。
- (e) 本規章有未盡妥善之處，主辦單位得隨時修訂，並提交大專執委會通過後實施。

# 2025 – 26 USFHK Women's Handball Competition

## General Rules



### A. Format of Competition

A single round-robin system will be adopted in the preliminary round if the number of participating team is six only. If the number of participating team is more than six, teams will be drawn into two groups. The top two teams in each group will qualify for the semi-final and final. Teams finishing at 3rd and 4th places in the groups will play for the consolation round, adopting the cross-elimination system.

### B. Regulations

Unless otherwise stated, the competition shall be organized in accordance with the rules of the game issued by the International Handball Federation (IHF) after 1 July 2025.

### C. Scoring

- (a) In all single round robin matches, the winner gains 3 points and the loser gains zero point. If the match ends in a draw, each team will gain 1 point. In case of walk over or forfeit, the score shall be recorded as 0:12 and gains zero point. Individual group positions will be ranked by accumulated points.
- (b) If two or more teams have gained the same number of points after the group matches have been completed, their ranking is decided based on the following:
  - (i) The winner of the match among the teams concerned shall be awarded the higher position.
  - (ii) Goal differences in the matches among the teams concerned. The team with the most goal differences shall be awarded the higher position. (Goal differences: goals scored minus goals conceded)
  - (iii) Total goals in the matches among the teams concerned. The team that scores the most goals shall be awarded the higher position.
  - (iv) Goal differences in all matches. The team that scores the most goal differences shall be awarded the higher position.
  - (v) Total goals in all matches. The team that scores the most goals shall be awarded the higher position.
- (c) If teams are still tied after all the above, a play-off will be conducted among the teams concerned. (Only applicable for deciding which team from each group may advance to the Semi-finals)
- (d) In case of a draw in full time in all single round robin matches, no overtime will be adopted. Each team will gain 1 point.
- (e) In the consolation round, the match winner will be decided by using 7-meter-throwing. While in semi-final and final competitions, overtime is played consist of 2 halves of 5 minutes, with a 1-minute half-time break. If the game is still tied, the decision is to use 7-meter-throwing as tie-breaker to decide a winner.

### D. Entries

- (a) Each institution is entitled to enter one team. The personal information with recent photos of the players should be put down clearly on the enrollment form, duly signed by the Council Member of the respective institution with school chop.
- (b) Each team may register and roster 16 players in each match.
- (c) Eligibility of players: Students born between 01/01/1990 to 31/12/2008 and registered for full-time studies at the respective institutions.

### E. Postponement

Request for postponement will not be entertained. Under special circumstances, the convenor has the right to change the competition schedule.

## **F. Referees**

Qualified/Certified referees will be recruited/hired for the referee/umpire services.

### **Withdrawal**

- (a) Any team not presenting a minimum number of players (not less than five) required for a particular game at the scheduled competition start time (according to the clock at the stadium, or Convenor's mobile device time if the clock is not available) shall be disqualified for the match.
- (b) During a match, the decision of the referee made according to the relevant rules of handball shall be final. Should a team oppose to the decision and refuse to play, the team shall be taken as withdrawing from the match.
- (c) If any team is regarded as having withdrawn from the match, the team should submit an official explanation signed by the Council Member of the institution concerned to the Chairman of the Executive Committee of USFHK within 72 hours (irrespective of holidays) of the event.

## **G. Protest & Appeals**

Each and every appeal must be made in writing and signed by the Council Member of the institution concerned. The appeal, accompanied with a deposit of Hong Kong dollars three thousand, shall be made within 72 hours (irrespective of holidays) of the event concerned, to the convenor and copied to the Chairman of Executive Committee. The decision of the Appeal Board shall be final.

## **H. Weather**

In case of adverse weather, the convenor has the right to postponement of the matches.

## **I. By-laws and Rules**

- (a) "Kampa Spectrum Synergy Pro size 2" will be used and shall be supplied by the Federation.
- (b) Uniform: In case of clash of colours, the Guest Team (which is listed second on the schedule) shall change.
- (c) Team Time-Out: NO ELECTRONIC BUZZER FOR REQUESTING A TEAM TIME-OUT. The GREEN card system remains enacted.
- (d) Video Replay Regulations are not applied in this competition.
- (e) The organizer reserves the right to amend and/or supplement the By-Laws, Rules and Regulations. The By-Laws, Rules and Regulations thus made will be submitted to the Executive Committee for approval and implementation.
- (f) In case of controversy over the rules/regulations between the Chinese and the English versions, the interpretation of the Chinese version shall be followed.
